# Scope of the Trustee:

#### The NSCSO Committee includes three Trustee Committee Members

The Trustees are concerned with everything happening inside and outside AA that may affect the health and growth of the Fellowship. The Trustees are close to the Northern Sydney Central Service Office activities and their duties are essentially custodial. The Trustees night also consider volunteering for some business interactive service activities.

### **Length of Sobriety:**

10 years of continuous sobriety is suggested but not mandatory. A Trustee Committee Member is a member of good standing and ideally having a minimum of ten years of continuous sobriety, although not mandatory, in the AA Fellowship and who has been elected to this position.

#### **Duration:**

Trustees serve a three (3) year term, concluding at the end of the third AGM after their election. Trustees rotate out of this service job after the three-year term unless the NSCSO Inc. Committee approves their eligibility to seek reelection.

Trustee's availability for consultation with the Committee members at any time. They are active members of the committee and make themselves available for the solution of problems about which committee or volunteer members may need help.

#### **Duties and Role**

The Trustee Committee Members role is to provide the Committee with guidance and leadership in undertaking obligations to AA service activities and business interaction with the Fellowship in Eastern Region, Atea E,

A Trustee Committee Member brings to the Committee their guidance, leadership and commitment qualities. The guidance and leadership qualities include;

- familiarity with AA principles
- experiences in AA service and elsewhere
- ability to deal with AA affairs with grace and a minimum of friction.
- Good leaders can bring to the Committee the quality of resoluteness and courage of their convictions, along with good judgment, objectivity and willingness to stand up and express themselves.
- being one of the authorised signatories for the banking facilities
- considering volunteering for some business interactive service activities (current activities undertaken by a Trustee include; (1) liaising with Kuring-gai Council in relation to the occupancy licence for the St Ives office and (2) appointment as Public Officer with NSW Fair Trading
